20.01.01 Apologies for Absence

20.01.02 Vacancies of the Council

As agreed at the December meeting this agenda item would be carried forward and no decision made.

The Clerk advised that there had been no interest in vacancies to date and it was hoped that the vacancy could be filled prior to or at our March meeting.

20.01.03 To Approve the Minutes of the meeting held 5 December 2019

The minutes were approved as an official Council record.

20.01.04 County Councillors Report

Councillor Radford had circulated an e mail to the Clerk ahead of the meeting and this is appended to the minutes. Councillor Radford also highlighted that the funding by County Council is somewhat squeezed and they are going through their budget setting process for 2021.

20.01.05 District Councillors Report

Councillor Warren was able to notify the meeting that the main modifications of the MDDC Local Plan were now out for consultation, all responses should be received by 17 February 2020. Councillor Warren highlighted that only the main modifications could be responded upon as opposed to the whole plan.

The Council is reviewing fly tipping charges with a view to increasing the penalty from £250 to £400 and it had been agreed that temporary cameras would be put up in particularly bad spots. There was also a policy being updated with regards to dogs and whether dogs are allowed in certain areas and the penalties for dog fouling. This will be consulted on and it is expected that the policy will be site specific as opposed to the whole of the district. In addition this will also cover recycling and those in the district who do not follow the recycling guidance.

Councillor Warren also advised that fellow Mid Devon District Councillor John Daw had passed away recently after a very long tenure within the Council.

Councillor Chesterton was able to advise that the budget setting for Mid Devon District Council was also ongoing at the moment and they were facing some difficult decisions to try to balance the budget.

A motion had been passed by Councillor Evans for funding available land to plant trees. It was advised that funding is often available but this is only where the land is ready to plant trees almost immediately and therefore the District had undertaken to identify the land which would then be available as and when planting options came forward.

There was also a motion put forward in that any new housing developments would include policy updates as they have last been reviewed some 8-9 years ago this included a policy item for electro vehicle charging and infrastructure required.

20.01.06 Finance

20.01.06.01 To Approve the December Financial Statement

The December financial statement was approved as official Council minutes.

There was a query raised with regards to the fence that had been installed along the long shrubbery and whether the length of fence was adequate. It was agreed that this would be reviewed and contact would be made by Mike Pollard to Stacey who had undertaken the works.

20.01.06.2 2021 Budget

The draft budget was discussed and updated during the meeting and a final copy is appended to the minutes.

20.01.06.03 Coldharbour Mill

The Clerk advised that the funding available to Coldharbour Mill from the Parish Council from the precepts from 18/19 and 19/20 would be carried forward to be spent during 20/21. The first grant of £5,000 had been agreed towards the cost of two shipping containers for storage on site whilst other works were carried out. However the Mill requires some preliminary work for the siting of the shipping containers and this works will commence in April hopefully. The other item had not been confirmed although it was anticipated that the funding would go towards a walkway around the meadow by the Leat Pond.

20.01.06.04 Ashill Play Area

The Clerk advised that the play equipment had been installed just before Christmas and the balance had been paid. Councillor Blackman was able to advise that Ashill had been successful in Tesco funding as well as Co-op funding and therefore they were now in a position to order a zip wire. As discussed within the budget funds were available from the 20/21 budget towards the cost of the zip wire and therefore the Council will cover this cost.

20.01.06.05 Uffculme Village Hall

The meeting did not have any details with regards to the refurbishment of the toilets and therefore this item was carried forward.

20.01.06.06 Uffculme Christmas Lights

The Clerk reminded Councillors of the costs incurred in respect of the Christmas Lights and advised that since the December meeting some additional invoices had come forward these totalled £247 net of VAT and the Clerk asked Council to consider whether they would look to request an additional donation from the Lights Committee for this cost. Councillor Mackian proposed that the Council cover the cost, this was seconded by Councillor Pollard and all of the meeting was in agreement.

20.01.06.07 Grass Cutting Contract 2020-21

The Clerk advised that she had circulated the tender documents to the agreed three Councillors before the meeting and that both Councillor Nash and Mackian recommended the grass cutting contract for 2020-21 be awarded to Jess Lucas. The meeting discussed the merits of each of the quotes we had received and the meeting agreed this was proposed by Councillor Nash, seconded by Councillor Wells and all of the meeting was in agreement.

As raised by Councillor Warren the Mid Devon Local Plan was out for consultation on the main modifications. The deadline for submissions was 17 February 2020 and the meeting agreed that the Council should make a representation. Councillor Wells offered to draft a response to the major modifications, and it was agreed the Clerk would forward items to him as previously submitted.

20.01.07.04 Uffculme Men's Club

Councillor Kingdom advised the meeting that work continued in respect of the works to install a disabled toilet on the ground floor. The committee continued to be very pleased with the financial support from the Parish Council.

The Club had expressed their sadness over the last week or so after the passing of Derek Ingersent, a long time and dedicated member of the Club.
